- I. <u>Call to order</u>: Meeting was called to order by Lucas at 1:04 pm; quorum established.
- II. <u>Approval of Meeting Minutes:</u> A motion to approve the meeting minutes for the May 2021 and June 2022 meetings was made by Lucas and seconded by Eric. Motion passed.

### III. <u>Review Recent Edits to AGIC Manual:</u>

- The workgroup reviewed the new Section 2: Code of Conduct.
  - Jenna asked if the manual should refer to Google Groups, like those used by AZGeo and the Data Committee.
    - Lucas clarified the term "AGIC Forums" already covers these platforms.
  - Eric asked that if copyrighted materials that are wrongly posted to the AGIC-L listserv, how would AGIC be able to remove those materials since they are emailed to all subscribers
    - Lucas will clarify the language in the manual to say that if copyrighted materials are wrongly posted to AGIC-L, AGIC will send a response.
  - The group modified the manual to include that both AGIC and the SCO have the ability to remove or block users from forums.
- The workgroup reviewed changes to Section 3: Serving on AGIC
  - The group approved the changes to the Requirements and

Etiquette section (now called the Participation section), where most of the language was removed and a reference to the new Section 2 was added.

- The workgroup reviewed changes to Section 6: Committees
  - Jenna asked to remove language suggesting public members-atlarge could not speak during meetings.
    - She felt the language could be misinterpreted and prevent some public members from speaking during the meeting.
      - While Robert's Rules of Order do suggest that public members cannot talk during meetings unless allowed to by the Chair, AGIC Committee and Workgroup meetings tend to be a more open environment and the workgroup agreed it would be better to encourage open dialog, even amongst public members-at-large.
    - The language was removed from the section
  - Jenna requested language be added to make it clear that voting members who miss three consecutive meetings for unexcused reasons would be automatically removed.
    - This is what she had been telling new voting members and felt the system worked well.
    - The language was added to the manual.
  - Eric asked if members who are removed should be given a formal notification, such as an email.
    - Lucas noted that it is the Chair's responsibility to ensure meetings make quorum and if people are not attending, then the Chair has the right to remove them without notice.
- The workgroup review Section 8: Obligations
  - Jenna requested Arizona Revised Statute 37-173 be referenced as the reason AGIC is involved in NSGIC.
    - Lucas will make the correction
- The workgroup reviewed the new Section 11: NSGIC
  - No edits were suggested.
- IV. Information or Topics for Future Meetings: No future meetings are planned. Lucas will make the corrections and present them at the next Admin & Legal Committee meeting scheduled for October. If the Committee approves the changes, Lucas will present them at the November Council Meeting for final approval.
