- III. <u>AZGeo Platform Discussion & Feedback</u>: Everything is working well. Ryan is working with the DFFMs-configuring the platform and installing them on the AWS servers, creating imagery and map services for NAIP Imagery from 2007 to present. The 2019 NAIP Imagery is currently available on the Open Data site, with the ability to have continuous color band changes on the fly. Ayan Mitra has

made updates to the 1spatial tools and moved ADOT's custom app over to ArcGIS Online. Kasey is adding more open data sites, both federal and local, to the Open Data platform.

- IV. <u>AGIC Education & Training Symposium</u>: There will a one hour long technical session ran by Kasey Green and Shea Lemar. Shea will touch on the data hub, how data is being added in open data, and metadata standards. Kasey will speak on an overview of hub, main pages, how to search, creating groups, capabilities one gets as a user, and how the data is stored in the backend. This is a higher-level training session.
- V. <u>AZGeo WG Sunset/User Group Creation Discussion</u>: The first meeting for this group will be scheduled soon. AZ Geo working group will continue meeting until Sunset has their first meeting. The User Group will be implemented to provide support to data users and feedback to the group.
- VI. <u>Information or topics for future meetings</u>: Next meeting is November 2<sup>nd</sup> at 10:30 am. Continue talk about the new Sunset Working Group and give updates on the platform.
