

2021 AZGeo User Survey

We are excited to share that since the release of the modernized AZGeo in July of 2020, we have added 448 named users to the system. These users have uploaded 484 data layers, created 51 groups and developed 67 applications within AZGeo which help them meet their daily business needs.

The AZGeo Advisory Committee has been meeting regularly and engaging AZGeo users to monitor the system, learn how AZGeo is being used, and learn what platform enhancements users feel would benefit the AZGeo community. In support of this outreach effort, we have developed this survey to gain insight and gather input from the people who use AZGeo.






