#### V. Review 2021 AZ SPCS2022 Zone Submission to NGS:

The AZ SPCS2022 Zone Submission to NGS is currently on a Google Drive that Jenna provided a link to, and there was talk about maybe making it available on AZGeo.

#### VI. Review NGS Memo from 6/15/2022:

Michael Dennis reviewed the memo that he sent out on 6/15/2022. The main idea of the memo was to announce a delay in modernization and make people aware, but it is not a big delay, and we are still in good shape. The other main purpose was to inform everyone of the timing. The intent is to review and approve all stakeholder submissions by end of September. The next step is to get all complete preliminary designs out to stakeholders by end of the year to get feedback. Then, finalized by early to mid-2023 then distributed. Michael then showed a map displaying the preliminary design for SPCS2022 zones and discussed potential changes.

#### VII. <u>ARS 33.131-138 Discussion:</u>

Brian mentioned that APLS (Arizona Professional Land Surveyors) has a committee that is working on ARS 33.131-138 and if you want more information, you can email him. The findings from that committee will be brought to this workgroup, then to AGIC.

## VIII. AZ SPCS 2022 Map Book Discussion:

Jack showed SPCS2022 zone maps and led a discussion about them. He mentioned that the maps shouldn't be published on AZGeo or the NGS site until they are finalized, but Jenna will get him access to a google drive for this workgroup where he will post them as drafts for the group to review. Sarah Burgi asked in the chat if we will have 1-3 overall state plane coordinate zones or just these low distortion projections. Brian answered that we will have a single statewide zone that performs better than the central zone did in the past, and the next layer is the smaller LDP's. Michael mentioned that a state can make their own projections and use them, but to be a part of the SPCS, they need to adhere to NGS policy.

### IX. Next Steps

 Education and Outreach - Working with statutes and the community at large regarding SPCS. There will be a 1-day seminar on 10/14 in Tucson, and Brian will be speaking at the AGIC conference in September.
