VII. **Outreach:** Justin Eddinger gave the following Green Drone Updates. All the curriculum and documentation for Green Drone AZ middle and high school programs is complete and has been distributed to teachers and partners. Currently around 40 schools are using the program. CSO career led expiration interviews are complete. Charlie Fitzpatrick from ESRI will be conducting an intro to ArcGIS/AGOL class for the teachers that will be recorded and shared.

VIII. **AZ Drone Fest Presentation:** Chris Tinard is a videographer/cinematographer, and he gave a presentation on the AZ Drone Fest, which will be held at Grand Canyon University on October 22, 2022. The vision of AZ Drone Fest is to bring all the different drone communities together, not just cinematographers. It will be 3 events in 1: Drone Expo, Drone Conference, Drone Film Festival. Chris then showed a video by Danny McGee who has won the film contest 3 years in a row.

IX. **Workgroup Update and Discussion:** Kasey led a discussion about a possible Merger with the 4D Geospatial Data Workgroup (formerly the Lidar Workgroup). The group discussed pros and cons, and everybody agreed that it is probably a good idea to merge the groups. Mark Christiano, the co-chair of the 4D Geospatial Data Workgroup will be present at the next UAS Workgroup meeting to discuss more details about the potential merge.
