- VII. Presentation Drone Imagery and Classification: Nick Bisley gave a presentation on "Successes and Challenges – Starting an Imagery and Drone Program for County Government". He noted that Pima County initially used imagery just for basemaps, but an increasing number of requests for more updated imagery led to the creation of an imagery and drone program. Nick also talked about the steps involved in building such a program, such as hiring GIS employees and ensuring that there is enough capacity/storage for the imagery, among other things. He also talked about using ESRI classification tools for identifying vegetation types.
- VIII. <u>Future Event Planning:</u> Kasey and Chuck led a discussion about planning for the upcoming Spring Fly-in. It was decided that Phoenix will be the best general location to host, with a more specific location to be determined later.
