Discussion on procedures and activities: Jenna led the discussion on procedures for topics/items to be brought to this group for consideration. An email or ticketing system was discussed. The group collectively agreed to use a form that notifies the generic azgeo@azland.gov account for users to submit bugs and enhancements. A collaborative space for tracking was discussed. Development of an FAQ was also discussed. This will be a future item for ASLD to work on.

Jenna shared that ASLD maintains an internal spreadsheet for routine activities and enhancements previously requested. There is one existing item for this group to discuss currently: Open Data and AGOL search functionality. There is not the ability for current search functionality to incorporate both catalogs and return results. If the group thinks this functionality is important then action will need to be taken. After discussion, the group agreed to have ASLD contact the Esri Hub team to find out if there is a plan to integrate this functionality and request a quote from the AZGeo Developers for what providing a custom solution would cost.

Action items: Jenna will create a google drive for group members to access, coordinate a form to be developed, and a link to be added to AZGeo indicating this. Jenna will send an email to the Esri Hub team regarding the search functionality and request a quote from ASU.

Jenna updated the group on the most recent activities and projects associated to AZGeo: Sun Cloud, ADOT Research Center, Broadband, AGIC Workgroups
