#### I. Call to Order:

Jenna Leveille called roll of Council members and attendance was recorded. Quorum was established. Shea Lemar called the meeting to order at 3:33 pm. Note: A copy of the agenda background material provided to members is available for public inspection at the Arizona Geographic Information Council's office at 1616 West Adams Street, Phoenix, AZ 85007, Room 216A.

#### II. Conference Platform Cvent Software Presentation / Discussion:

Steve Whitney presented the conference committee's request for the council to consider purchasing conference planning software. Slideshow included, labeled Addendum A, and utilized for the presentation and discussion. A motion to direct the conference committee to procure the Cvent software for the next two years was made by Steve Whitney and seconded by Jason Howard.

Discussion followed that included how training and 10 administrator accounts are included with the software package. Another topic included the consideration that the software is designed for both virtual and in person events, which brought up the possibility of utilizing the software for other events outside the annual symposium. Jenna clarified that the current pricing allows up to 500 attendees but can be allotted to multiple events; Jenna also noted that the package would need to be renewed in two years to prevent the return of the extensive work the software is performing, including all the items in the slideshow, but also the packaging / hosting and streaming of recorded content, which took an extensive amount of time last year for an amateur (non-professional) final product. Other known organizations utilizing the Cvent software with success were pointed out, like North Carolina with over 700 attendees for their state conference. Also discussed was the entry price point which could not be lowered without sacrificing necessary features. Another topic brought up was the motivation behind procurement of the software, specifically to bring new leadership into the conference committee. Steve shared that the software would provide any incoming leadership with additional tools and part of the motivation was to eliminate the need for one person, like Jami, to have such a heavy lift every year. Once the pandemic hit, it moved this to the forefront of needs. Financial impact to the budget was also discussed with the conclusion that the conference committee can budget for the software without causing a hardship or limiting the ability for

the AGIC council to provide annual sponsorships, like NSGIC attendance. A cost savings was noted through the elimination of the annual fees for the mobile app. A vote was held, and the motion passed unanimously with no abstentions.
