Tolleson Amazon drone crash last week - no one was hurt but brings up a beyond visual line of sight argument

H.R.2864 - Countering CCP Drones Act - passed the house in September 2024, stuck in Senate committee "Senate Commerce, Science, and Transportation"

H.R.1907 - Defense Against Drones Act of 2025 - allow for a citizen to shoot a drone flying under 200ft above their property

1:35 pm (Hold for) 3DEP Lidar Collection update from Cynthia Ritmiller from USGS

Cynthia was unable to attend this meeting, notes were provide for discussion.

Currently, 16% of Arizona LiDAR is currently in work. Data is either being collected or reviewed. 82% has passed validation, and has been or will be Published over the next couple of weeks. There is 2% of Arizona that USGS is not planning to collect per Tribal requests. Both Mohave and Coconino Counties have passed data validation and are queued to be published to the servers. Shea Lemar added that drones are reflown as often as they can be. However, funds come from partnerships between USGS and a lot of other Federal groups. If the Lidar is new enough, then it can be used for 3DHP, for Hydrography created from Elevation Data.
