Jack Avis motioned, Pat McGarrity seconded. Passed unanimously

9:07 am (2:41) Update on current state of the SPCS2022 activities (Brian Fisher)

 Review of preliminary data as posted on the NGS website, https://alpha.ngs.noaa.gov/SPCS/index.shtml

A few zones submitted from AZ that weren't approved; preliminary designs posted July 2023; NGS needs confirmation that AZ is good with the preliminary designs. No feedback has been received thus far. Comments should be submitted to the chairs of this workgroup by Feb 29. The group will meet on Feb 29 at 9am and formally approve preliminary designs. Michael Dennis will make adjustments if he receives them before this date. He will send out a full check of coordinate extents and distortion performance statistics for each zone next week for this group to review. Brian wants to make certain the community has sufficient time to review and comment on the preliminary designs.

Adjustment data for GNSS need to be submitted to NGS by Feb 29. Data will still be accepted after that deadline but will not be integrated in the first round of updates.

9:20 am (20:55) Present the proposed updates to Arizona Statutes, as prepared by members of the geospatial and land survey community (Brian Fisher)

Draft circulated to the workgroup with the meeting reminder. Discussion on the draft by the group. Some concern about not including 'state' in the name – would this cause confusion. Item A explains that Plane and State Plane are interchangeable. APLS Strate Board of Directors have voted to approve the proposed language as distributed – recommending moving forward. Seven states have already approved new legislation. An additional nine states, including Arizona, have drafted legislation. No other comments were made.

9:30 am (28:36) Discussion on next steps for updating the statutes

APLS Board in discussion on next steps. SRP has been approached to sponsor this bill; they do not have the bandwidth to do this. APLS is planning to file the paperwork for consideration/sponsorship. APLS is interested in getting stakeholder support and providing awareness. APLS would like correspondence from AGIC noting there is no objection to the proposed legislation (including background on AGIC Members and organizations they represent). Important to classify this change as technical.

Additional outreach and education to stakeholders regarding legislative update are suggested. Brian asked that the group email any additional stakeholders to include for consideration.
